INTRODUCTION

Herbert R. Donica, the Court-appointed receiver (the "Receiver") over the assets of HRK Holdings, LLC (the "Receivership" or "Receivership Estate") files this Status Report for the Fourth Quarter 2022 and Annual Status Report for 2022, to inform the Court, creditors, and others interested in this Receivership of activities to date and the Receiver's proposed course of action.

BACKGROUND

I. Procedure and Chronology

The Piney Point plant (the "Facility" or "Piney Point Site") is an industrial site in Manatee County, Florida, and the location of a former fertilizer plant. The Facility holds stacks of phosphogypsum, a byproduct of fertilizer production, and pools of polluted water (the "Stack System"). The Stack System holds about 480 million gallons of process water. The owner of the Piney Point Site, HRK Holdings, LLC, is believed to be insolvent. In November 2020, FORTRESS 2020 LANDCO, LLC, the mortgage holder, started foreclosure proceedings on the site (the "Foreclosure Case")¹, seeking to recover portions of the property not directly associated with the Stack System. HRK Holdings, LLC has effectively abandoned the Piney Point Site.

On March 25, 2021, the Facility's owner reported conditions indicating that a part of the Stack System could begin to fail. The Facility began controlled discharges to reduce pressures and prevent failure of the Stack System on March 30, 2021; however, based on reported conditions at the Facility on April 3, 2021, precautionary evacuations were ordered in the vicinity and were followed by the issuance of a state of emergency order later that day, by the Governor of Florida. This episode required approximately 215 million gallons of contaminated water to be discharged into Tampa Bay to prevent a collapse of the Stack System.

On August 25, 2021, in the Foreclosure Case, the Manatee Circuit Court entered an order (the "Order") (Doc. No. 77) appointing Herbert R. Donica as a Receiver to take control of the Facility and oversee its expeditious closure. Pursuant to the Order, the Receiver is charged with "maintain[ing], manag[ing] and clos[ing] as efficiently and expeditiously as possible the Facility in

accordance with all applicable State and Federal laws." The purpose of the Receivership is to maintain, repair, and close the Stack System so that it is no longer a threat to public safety and the environment.

II. The Receivership Process

On August 5, 2021, counsel for the Florida Department of Environmental Protection (the "FDEP") filed a Motion for Appointment of Receiver (Doc. No. 69) in the Foreclosure Case. All the active parties in the case stipulated to appoint a Receiver to take control of the property (Doc. No. 80). On August 25, 2021, the Court appointed Mr. Donica as Receiver (Doc. No. 77).

Although the FDEP recommended Mr. Donica's appointment as the Receiver, the Receiver is an agent of the Court – not an agent or employee of the FDEP. To ensure that the Court is informed of the Receiver's activities, the Order Appointing Receiver (**Doc. No. 77**) requires the Receiver to file Status Reports.

To ensure the activities of the Receiver and his professionals benefit the Receivership Estate or are otherwise appropriate, the Receiver first reviews all invoices and makes any necessary adjustments. The Receiver is required to submit his applications for the payment of fees and costs first to the FDEP for review and then to the Court for approval. The Receiver regularly communicates with his professionals and interested parties to ensure his activities benefit the Receivership Estate or are otherwise necessary.

The Receiver has engaged an engineering firm, Ardaman & Associates, Inc. ("Ardaman"), to design the work to close the Stack System, and to provide closure construction quality control testing and conformance oversight. Ardaman assisted the Receiver with the development of bid packages for the work.

When the Receiver determines that the project is complete, the FDEP will evaluate the results to determine that the closure was performed in accordance with requirements of Rule 62-673.620, F.A.C. Upon determining compliance, the Department will issue a Closure Letter to the Receiver. The Closure Letter sets the official date of closing and the beginning of the long-term care period pursuant to Rule 62-673.630, F.A.C.

After issuance of the Closure Letter, the Receiver will move the Court to close the Receivership along with a final report and an accounting.

The Receiver believes these procedures and safeguards will allow him to close the Stack System in an efficient and cost-effective manner. The Receiver estimates the project to be completed by the end of 2024.

III. Overview of the Receiver's Activities

The Order Appointing Receiver (**Doc. No. 77**) authorizes, empowers, and directs the Receiver to manage and undertake closure of the Facility. Consistent with his responsibilities, the Receiver has:

- 1) Purchased materials for remediation of the Old Gyp Stack South (OGS-S").
- 2) Entered into a contract with Forgen, LLC to perform construction activities on OGS-S.
- 3) Coordinated deliveries dates with materials suppliers.
- 4) Completed negotiation with Manatee County for the construction and operation of a pretreatment water facility and deep injection well.

IV. Funding the Receivership

The FDEP has agreed to fund the Receiver to perform his duties under the Order (**Doc. No.** 77) from funds appropriated by the Florida Legislature. The FDEP and the Receiver have entered into a Maintenance and Funding Agreement (the "**Agreement**") that outlines the activities to be undertaken by the Receiver and identifies the projects to be managed. As of this date, the FDEP has distributed *\$43,980,637.21* to fund the Receiver's activities.²

The State of Florida's performance and obligation to pay under the Agreement is contingent upon an annual appropriation by the Legislature. The Agreement is not a commitment of future appropriations.

V. Actions Taken by the Receiver

The First Status Report for the period of August 25, 2021, through October 31, 2021 (**Doc. No. 95**) was filed on November 2, 2021 and covered the first 10 weeks of the Receivership. The Receiver filed his Second Status Report (**Doc. No. 120**) on January 10, 2022, and covered the period of August 25, 2021, through December 31, 2021. On April 22, 2022, the Receiver

filed his First Quarter 2022 Status Report (**Doc. Nos. 148 and 149**) covering the period of January 1, 2022, through March 31, 2022. On July 11, 2022, the Receiver filed his Second Quarter 2022 Status Report (**Doc. No. 164**) covering the period of April 1, 2022, through June 30, 2022. On October 7, 2022, the Receiver filed his Third Quarter 2022 Status Report (**Doc. No. 184**) covering the period of July 1, 2022, through September 30, 2022.

The Receiver filed Monthly Progress Reports for July, August, September, October, and November 2022 (Doc. Nos. 175, 179, 187, 192, and 214) detailing the status of planned closure activities, and a monthly updated water balance projection, including corresponding water removal rates for closure, and projected future closure schedule dates.

The activities of the Receiver detailed in the First and Second Status Reports, and the First, Second, and Third Quarter 2022 Status Reports, and the Monthly Progress Reports for July through November 2022 are incorporated by reference herein. All the Receiver's actions have been undertaken pursuant to the Order Appointing Receiver (**Doc. No. 77**).

The Receiver has met with the mortgage holder Plaintiff, Fortress 2020 Landco LLC to discuss status of the project and the Conceptual Closure Plan submitted to the FDEP. The Conceptual Closure Plan includes Hydrologic and Hydraulic Evaluations that illustrates how storm water will be managed post-closure. The Receiver and Plaintiff are working together to identify new boundary lines of the parts of the property subject to the Plaintiff's foreclosure.

Overview of Significant Activities During This Reporting Period

Several significant and notable goals were successfully achieved during the Fourth Quarter of calendar year 2022 in addition to continued routine operations to move toward closure of the Facility as expeditiously as possible.

Significant Activities

- Conducted site visit and met with site manager. Surveyed effects of Hurricane Ian and took pictures.
- Prepared and filed Receiver's Third Quarter 2022 Status Report with the Court (Doc. No. 184).
- Reviewed September Progress Report provided by engineers, reviewed and revised Receiver's Supplement and filed with the Court (Doc. No. 187).
- Reviewed and approved contractor's change order.
- Prepared construction funding request and related exhibits and worksheets.

- Reviewed contractor's progress payment worksheet.
- Prepared materials and attended 35th Annual Regional Mining Conference; presented Piney Point update.
- Coordinated delivery schedules with materials suppliers.
- Worked with environmental engineers to review and complete an updated NPDES permit renewal application.
- Prepared monthly financial reports.
- Prepared budget requests for distributions from the Long-Term Care Escrow Fund managed by the FDEP for the monthly operating budgets.
- Prepared and submitted funding requests and construction budgets for draws from funds earmarked for closure of the Stack System; responded to requests by FDEP for changes to funding requests and for the production of additional information and documentation.
- Conducted meetings with FDEP and mortgage holder's legal representatives to establish boundary lines and access easement.
- Prepared package of materials for Florida State Representative Mike Beltran.
- Attended weekly project meetings with contractors and engineers.
- Multiple telephone calls with media re site status pre and post hurricane.
- Met with engineers to review weather delay terms in contractor's contract.
- Reviewed existing easements to determine right of ingress/egress post foreclosure. Draft memo to file and notate maps illustrating need for additional access.
- Communicated with site manager and RIPA representative re soil purchase agreement and related.
- Completed negotiations of proposed agreement with Manatee County for haul damage protection.
- Corresponded with FDEP and provided additional information for updating the NPDES permit renewal application.
- Attended several telephone conferences with environmental engineers to review the updated application for NPDES permit.
- Conducted regular meetings with FDEP, ECT, site manager and Ardaman re discuss NPDES Permit.
- Participated in multiple telephone calls and emails with FDEP staff and site manager re status of NPDES application and notice of intent to issue permit.
- Conducted several meetings with engineers and contractor re shortage of high-strength fabric.
- Attended Weekly Project Meetings with engineers, contractor, and site manager.

- Researched procurement files, purchase orders, emails with suppliers, invoices and file notes to determine quantities of high-strength fabric ordered and delivered.
- Communicated with engineers and supplier to place purchase order for 22 additional rolls of Mirafi 770 Geotextile; prepared purchase order and completed order.
- Participated in multiple email communications with site manager, RIPA, and Trans-Phos re status of haul permit.
- Performed all necessary accounting tasks including bank account reconciliations, payroll management, payables management, and tracked and recorded payment of expenses.
- Review October Progress Report provided by engineers, review and revise Receiver's Supplement and file with the Court.
- Reviewed and approved contractor's change order.
- Reviewed contractor's progress payment worksheet.
- Continued discussions with mortgage holder's legal representatives to establish boundary lines and access easement.
- Finalized Service Agreement, execute and filed Motion to Approve Service Agreement after approval by the Manatee County Board of Commissioners with package of related exhibits. (Approved at a hearing on November 28, 2022).
- Researched and identified conservation groups, assemble contact list.
- Reviewed proposed revised method of procurement. Multiple meetings with Special Counsel.
- Participated in conference calls and on-site meetings with site manager, Phillip Locke and Laurel Smith with McKim & Creed, and FDEP re: review potential early start to disposal of wastewater.
- Conferred with IT vendor to upgrade network and related.
- Prepared monthly financial reports.
- Attended Weekly Project Meeting with engineers, contractor, and site manager.
- Co-ordinated efforts to secure the premises from possible effects of Hurricane Nicole.
- Conducted post-hurricane site visit and meeting with site manager. Surveyed effects of Hurricane Nicole and took pictures.
- Coordinated delivery schedules with materials suppliers.
- Met with engineers to review weather delay terms in contractor's contract.
- Corresponded with AXOS Bank and County attorney regarding form of Letter of Credit to secure pavement bond, as required by Manatee County to allow trucks to transport needed fill material from local Manatee County borrow pits to the Facility.
- Performed all necessary accounting tasks including bank account reconciliations, payroll management, payables management, and tracked and recorded payment of expenses.

Significant activities reported in the First, Second, and Third Quarter Status Reports (Doc. Nos. 148 and 149; 164 and 184), respectively, are incorporated by reference.

VI. Management of the Receivership Estate

When the Receiver was appointed, there were six on-site employees managing the Stack System and related property. The Receiver has increased staff to nine full time on-site employees to oversee and maintain the property.

The Receiver has negotiated agreements with key service providers and suppliers.

As part of ongoing water management activities, the Receiver has continued to use the services of a contractor providing an innovative water treatment process.

The innovative water treatment process has reduced the levels of nitrogen and phosphorus ("nutrients") in the New Gyp Stack South (NGS-S) by over 95%. By reducing the nutrient levels in the water in the NGS-S, the risk of causing or exacerbating algae and/or red tide outbreaks is substantially reduced if the water is discharged into the bay.³

The Receiver is performing all accounting, payroll, and administrative activities. The Receiver believes that the current staffing is adequate to support the activities of the Receivership, but more employees may be needed as additional construction activities are started.

VII. Retention of Professionals

In the Court's Order Appointing Receiver (**Doc. No. 77**), the Court allowed the Receiver to employ independent legal counsel to provide legal advice to the Receiver. The Receiver has employed the Standley Law Office, P.A., (**Doc. No. 110**) and Fox Rothschild LLP (**Doc. No. 112**). The Standley Law Office will assist in filing routine pleadings. Fox Rothschild LLP is a law firm with expertise in complex commercial litigation, insolvency matters, regulatory proceedings, construction law, and federal procurement matters. Fox Rothschild will primarily assist the Receiver with respect to procurement, contracts, and potential litigation issues.

³ The Receiver does not plan to discharge wastewater into the bay unless exigent circumstances require consideration such as an imminent tropical storm, hurricane, or a heightened possibility of a Stack sidewall failure. The Receiver will discharge collected stormwater into the bay from time to time pursuant to a permit issued by the Department. The stormwater is segregated from the site's wastewater and is tested prior to discharge.

The Receiver has engaged consulting engineers on an as needed basis to review and comment on water management issues and methods. The consulting engineers will be used in other capacities such as contractor evaluations and related matters as needed.

The Receiver is considering the engagement of an independent program manager to coordinate efforts of the contractors that will perform construction activities and to advise as to logistical issues that will arise.

VIII. Receiver's Accounting

The Receiver established a Receivership Bank Account (Account # 0017) at Axos Bank on August 30, 2021, for deposit and disbursement of funds received from the HRK Long Term Care Escrow Fund. The Long-Term Escrow Fund is used for day-to-day maintenance and operations of the property.

The Receiver established a Receivership Bank Account (Bank Account # 0025) at Axos Bank, for deposit and disbursement of funds distributed by the FDEP pursuant to the Maintenance and Funding Agreement between the FDEP and the Receiver. The funds are to be used to close the Stack System at the Piney Point site. The account is an interest-bearing account.

IX. Pending and Contemplated Litigation

A. <u>Pending Litigation</u>.

The Receivership is not currently involved in any litigation. When the Receiver was appointed, four pending cases against HRK Holdings, LLC. The receivership is not a party to the cases.

The Manatee Circuit Case No. 2020-CA-4459, Fortress 2020 Landco, LLC v. HRK Holdings, Arsenal Group, William Harley, FDEP, Ardaman and Associates, et al., is a foreclosure case brought by the mortgage holder, Fortress 2020 Landco, LLC against HRK. On August 24, 2021, the parties stipulated to the appointment of the Receiver (**Doc. No. 80**). The case has been informally stayed pending a proposal to permit Fortress to foreclose on selected parcels after an engineering plan is approved that will also determine the Receiver's ingress and egress needs.

B. Potential Litigation.

A former employee has engaged counsel and has demanded payment for a claim of overtime hours. After reviewing timecards submitted by the employee, the Receiver has determined that the claim is without basis. The former employee's timecards were provided to his counsel. As of this date the former employee has not sued.

X. The Next Ninety Days.

During the next 90 days, the Receiver will continue to collaborate with engineers to monitor Stack System Closure activities and develop bid packages for future construction and closure work. The Receiver will also continue to review and use methods to decrease the water levels in the Stack System until the deep injection well project begins operation. A more definitive time estimate of final Stack System Closure will be available as the project advances.

XI. Conclusion.

The Receiver has received many emails and telephone inquiries regarding the status and plans for the Piney Point site and has had to spend significant resources to address them. The Receiver continues to encourage individuals or entities having information helpful in closing the Stack System to email him at herb@pineypoint.org.
